Mr. Bob Hein asked if the Board of Education currently provides any services to homeschooled children. Mr. Smith stated no. Mr. Hein asked if there is a requirement regarding how long a class period must be to qualify as a credit; can we go to 10 periods, for example to allow for more classes? Mr. Smith confirmed that there are no standardized hours per period and 8 periods a day provides for classes as short as they should be.

Ms. Irene Kuck, 11 South Main St., asked Mr. Smith if there had been any feedback from school club / activity advisors regarding the proposed changes to the homeschool policy? As a former club advisor, she expressed concern with having to take on children who are unknown to the school community (behavior, safety, etc.). Mr. Smith advised that the district insurance policy would only allow these children to take part in certain activities – those that take place in the school itself and not offsite. Requests would be handled on a case-by-case basis.

Ms. Tania Sones, 17 Curry Ln, stated that the Board should understand that residents and parents will stand behind a responsible education budget that continues to move the district forward. She stated that residents need the BOE to stand behind the budget too. Ms. Sones pointed out that enrollment is down just 18 students compared to several years ago

and yet we are down 6-8 teachers. She stated that the education system is a huge value to the community.
